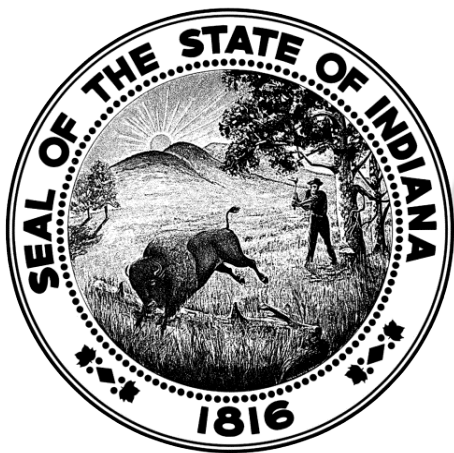

The undersigned Incorporator or Incorporators, desiring to form a corporation (hereinafter referred to as the "Corporation") pursuant to the provisions of the Indiana Not-For-Profit Corporation Act of 1971 (hereinafter referred to as the "Act"), execute the following Articles of Incorporation:

ARTICLE I Name

ARTICLE IX Provisions for Regulation and Conduct of the Affairs of Corporation

Other provisions, consistent with the laws of this state, for the regulation and conduct of the affairs of the Corporation, and creating, defining, limiting or regulating the powers of the corporation, the directors or the members of any class or classes of members are as follows: (Can be provided for in the "By-Laws") (Any provision in this section may only be changed by amending the Articles of Incorporation.)

SECTION 1: THE BOARD OF DIRECTORS OF THE INDIANAPOLIS YOUTH GROUP SHALL CONSIST OF A MAXIMUM OF NINE MEMBERS (9), and shall be charged with the responsibility of handling regular business for the organization.

SECTION 2: A simple majority vote of Board members attending a meeting of the board shall be required to conduct and approve business matters and issues before the board. A quorum of the Board shall consist of five (5) members.

SECTION 3: Regular meetings of the Board of Directors shall be held approximately monthly, or as otherwise determined by the board.

SECTION 4: OFFICERS OF THE BOARD OF DIRECTORS SHALL CONSIST OF THE FOLLOWING: PRESIDENT, VICE-PRESIDENT, and TREASURER/SECRETARY.

SECTION 5: DUTIES OF THE PRESIDENT OF THE BOARD OF DIRECTORS SHALL INCLUDE: CONDUCT ALL MEETINGS OF THE BOARD, REGULAR MEETINGS OF MEMBERSHIP, and SPECIAL MEETINGS; sign contracts and agreements with approval of Board.

SECTION 6: DUTIES OF THE VICE-PRESIDENT SHALL INCLUDE: PERFORM DUTIES OF PRESIDENT IN ABSENCE OF PRESIDENT and other duties assigned by Board.

SECTION 7: DUTIES OF THE TREASURER/SECRETARY: HAVE CHARGE OF THE FUNDS OF THE CORPORATION, MAKE MONTHLY FINANCIAL REPORTS, and record minutes of the Board and membership meetings. Also handle all correspondence.

In the event of dissolution of this group, the remaining assets after satisfaction of all debts and obligations shall be distributed for purposes strictly governed the requirements of Sect. 501(c)(3) of the Internal Revenue Code of the U.S. Treasury or the appropriate successor. The undersigned, being one or more persons, do hereby adopt these Articles of Incorporation, representing beforehand to the Secretary of State of the State of Indiana and all persons whom it may concern, that a membership list or lists of the above-named corporation for which a Certificate of Incorporation is hereby applied for, have heretofore been opened in accordance with the law and that at least three (3) persons have signed such membership list.
